How to apply

The request for the partial exemption must be made by email to formazione@polidesign.net by 30/04/2018 h 23.59 (GMT+1 – Italian time).

Partial exemptions are only available for those who will submit the application for selection and participation in the 1st level Specializing Master in “FIBER DESIGN AND TEXTILE PROCESSES”, year 2018/2019 Decreto Rep. n° 3681 Prot. n° 57391 Data 27.06.2017.

Assignment Criteria

Partial exemptions are awarded on the basis of merit criteria and on the basis of the requirements present in ART. 5 of Decree Rep. n° 3681 Prot. n° 57391 Date 27.06.2017.

In evaluating candidates and assigning partial exemptions, the Master Board will consider:

- Educational background (40%);
- Professional Experiences (30%);
- Motivation (30%).

The score will be expressed in a scale from 1 to 5 points, candidates obtaining a score of more than 360/500 points will be eligible for the partial exemptions.

The minimum score to be eligible for the Specializing Master is 300/500.

With the same score, the partial exemption will be awarded to the youngest candidate.

Those eligible for the Master who receive a score of less than 360 points and more than 300 points may formalize their enrollment before 30/04/2018.

To request partial exemptions, candidates must send the following documentation to formazione@polidesign.net:

- Admission form (available here:);
- Curriculum vitae;
- Portfolio (not mandatory);
- Self-certification relating to personal identity (name and surname, date and place of birth, nationality and residence);
- Photocopy of the academic transcript in the original language detailing the marks obtained for each examination, plus the translation in Italian, English, French or Spanish, or the Diploma Supplement;
- Copy of the identity document or passport for the extra EU citizens.

SELECTION AND COMMITTEE OF THE MASTER

The evaluation of the applications will be carried out by the Committee of the Master Course reported in art. 1 "Master Characteristics" Decree Rep. n° 3681 Prot. n° 57391 Data 27.06.2017.

The evaluation will be carried out by the Commission of the Master Course.

Partial exemptions are not cumulative.

The assignment of partial exemptions will take place during the selection process and admission to the Master, and never after the start date of the didactic activities.

DEADLINE FOR COMMUNICATION OF PARTIAL EXEMPTIONS

The selections will take place in chronological order according to the date of receipt of the application, as long as the available seats are exhausted.

The deadline for requesting the partial exemptions is on **30/04/2018 h 23.59** (GMT+1 – Italian time).

Only candidates who have reached the highest scores will receive written notice of partial exemptions from POLI.design by **07/05/2018**.

The awarded party must deliver to POLI.design a statement of acceptance of the partial exemption no later than **11/05/2018** or will lose the right on the same, and the awarding of the exemption will be processed to the candidate or candidates immediately following in the ranking.

From the moment of the acceptance, the candidate must proceed to the payment of the first instalment no later than 28/05/2018. If the candidate won't pay and subscribe the Private Agreement, the partial exemption will be automatically considered rejected and the Master Course Committee, at its sole discretion, will be able to recognize it to the next candidate in the ranking.

The registration is formalized with the payment of the first instalment to POLI.design and with the subscription of the Private agreement.

The initiative is valid until **30/04/2018**.

POLI.design reserves the right not to activate the Specializing Master in the event that a sufficient number of members has not been reached or in the event that the necessary teaching, logistics and administrative support requirements are missing for any reason. In such cases, partial exemptions will not be assigned, without any right of compensation.

POLI.design reserves the right not to allocate all available partial exemptions, if there are no candidates with the appropriate requirements.

All partial exemptions can be modified without notice.
